PARTICIPATION & ENTRIES

Herefordshire Charitable Art Competition 2018 ("the Competition"), being run by Harrison Clark Rickerbys inc Gordon Lutton ("HCR") of Thorpe House, 29 Broad Street, Hereford, Herefordshire HR4 9AR is open to all residents of Great Britain and Northern Ireland who are over the age of 8 years.

Participation in the Competition is free of charge, and no purchase is necessary to enter the Competition.

If you are under the age of 18, you must obtain written parental or guardian consent to enter and claim your prize. HCR may ask the winners to provide proof of age, and (if relevant) parental or guardian consent.

Participation will be by way of submitting an original piece of artwork created by the entrant and completing the following sentence: "Herefordshire is my passion because..."

Submission of artwork must be accompanied by a completed entry form, which can be found online at www.hcrlaw.com or can be collected from the reception of HCR at Thorpe House, 29 Broad Street, Hereford, Herefordshire HR4 9AR. The completed entry form and artwork is to be submitted at the above office of HCR by 5pm on Friday 19 October 2018.

Entries will only be eligible if a full name is provided, together with a relevant email address and/or telephone number.

Paper on which to create the artwork, if required, will be available to collect by entrants free of charge from the reception of HCR.

TIMING

The opening date for entries is 9 am on Monday 3 September 2018 ("the Opening Date") and entry closes at 5 pm on Friday 19 October 2018 ("the Closing Date"). Winners will be chosen on Monday 12 November 2018 by a panel of judges.

No entries received after the Closing Date will be admitted to the Competition.

PRIZE GIVING & DRINKS RECEPTION

Winners will be announced and prizes presented at a drinks reception on Monday 12 November 2018 ("the Drinks Reception") at All Saints Church, High St, Hereford HR4 9AA ("All Saints Church") and will subsequently be announced on HCR's website and in the media, along with photographs of the winners with their work.

Thereafter all the entries including the winning artworks will be exhibited for public view at All Saints Church for a period of 5 days ("the Exhibition") commencing on the day of the Drinks Reception. HCR reserves the right to display selected artworks, including the winning artworks, throughout HCR's Hereford offices for a minimum period of 6 months, thereafter continuation of display of the artwork will be at the entrant's discretion.

Each winner will nominate a charity, which will receive £250.00. The nominated charity must have a geographical connection to Herefordshire.

HCR reserves the right to announce and award more than one prize per age group and per category as it sees fit.

If a winner is unable to attend the Drinks Reception, their prize will be presented at a date to be agreed with them.

ENTRY REQUIREMENTS

Entries may be drawings, paintings, photographs or multi-media, but in all cases must be capable of being hung on an internal wall. The minimum size should be 297mm x 420mm and the maximum should be 900mm x 1400mm. Works should be entered in one of the following five categories:

- City
- Portrait
- Landscape
- Leisure
- Wildcard

There are two age groups for each category:

- Junior (8-14 years)
- Adult (15 years and up)

Each entry, which must include the entrant's name on its reverse, must be accompanied by a completed entry form which includes a name, address, age, contact details, parental and guardian consent (if relevant), and the completed sentence "Herefordshire is my passion because...", with an additional sentence or description about the subject of the artwork, including where and what it is. Forms are available from www.hcrlaw.com or from HCR's office at Thorpe House, 29 Broad Street, Hereford, Herefordshire HR4 9AR.

RULES & JUDGING

All entries must be original and created by the entrant named on the entry form. All entries must also relate to Herefordshire.

All entries must be entered in only one category and age group.

All entries must be accompanied by a completed entry form.

All entries must be submitted by 5 pm on the Closing Date to the HCR office at Thorpe House, 29 Broad Street, Hereford, Herefordshire HR4 9AR.

If entries are not framed and ready to be hung, HCR will make them ready for display; that process will be under HCR's control and at HCR's cost.

All entrants must be willing, if they win, to appear in the media (including social media) and on video at HCR. In the case of entrants under 16, permission for entry given in writing on the entry form by a parent or guardian will be taken as consent for such appearances.

Judging will be carried out by a panel assembled by HCR. They will consider:

- How the artist has expressed their passion for the county within their artwork;
- How the artwork reflects the character of the county; and
- Its impact in the space where it will be hung.

The decision of the judges is final and no correspondence will be entered into on the subject of their decision.

All winning submissions will be displayed in public following the judging, and may thereafter be hung in HCR's offices.

Whilst every care will be taken by HCR and its employees towards the safe handling and safe keeping of artworks entered in the competition, HCR shall not be liable for loss or damage to artworks on its premises, at All Saints Church, during delivery and collection to and from All Saints Church, nor during the framing (if any) of the artwork whether due to negligence of HCR, its employees, its Agents or otherwise.

All artworks which are not selected for display at HCR's Hereford offices must be collected by the entrant within 28 days of the date of the Drinks Reception, namely on or before Monday 10 December 2018. The first available date for collection of artworks will be Friday 16 November 2018, being the final day of the Exhibition.
