Over 200 years of legal advice...

Harrison Clark Rickerbys is an amalgamation of a number of firms, with roots going back to 1796, when Rickerbys was first established in Cheltenham.

The original Harrison Clark solicitors' practice was established in Worcester in 1904. The name comes from Colonel Roy Harrison.

In 1965, the firm became Harrison Clark when Tony Clark and Colonel Harrison merged.

The firm merged with Shawcross Solicitors in 2011, to become Harrison Clark Shawcross in Ross-on-Wye. The original Shawcross practice has roots in Ross-on-Wye that can be traced back to 1820.

A merger with Gordon Lutton, founded in 1982, created the largest firm in Hereford. Colin Gordon still works in the firm. In 2017, client demand resulted in a London office move to a permanently-resourced location.

Worcester remains the Head Office, while we have additional offices in Cheltenham, Hereford, London, Wye Valley, Birmingham and the Thames Valley.

1796

Our roots go back to 1796

A merger of two established Worcester firms led by Colonel Roy Harrison and Tony Clark.



1996

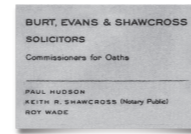
Becoming Rickerby Watterson

2011

A merger across Herefordshire

Harrison Clark LLP merged with Shawcross & Co Solicitors, whose roots can be traced back to 1820, creating Harrison Clark Rickerbys inc Shawcross. Keith Shawcross still works with the firm, aged 76.

2013

Medical Accident Group acquired and clinical negligence work moved into a separate legal entity.



2016

A merger with Simon Jackson Solicitors

Merger with Simon Jackson Solicitors, fisheries expert.

2018

Now with more than 470 staff, the firm has more than 65 partners operating from eight offices.

Becoming Rickerby Jessop

Rickerbys and Jessops merged in 1988 to form Rickerby Jessop, becoming Rickerby Jessop Flint in 1990.

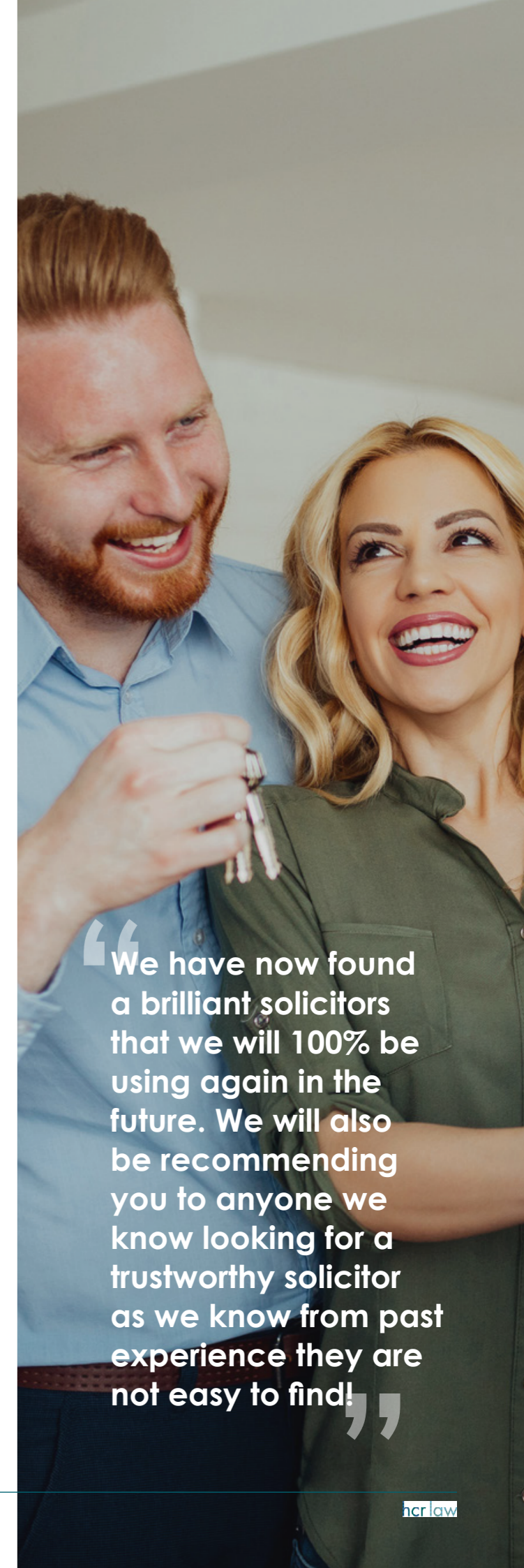

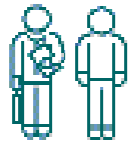

PRE EXCHANGE



Solicitor

- Issue draft contract to buyer's solicitor
- Request redemption statement and send on to client
- Respond to enquiries from purchaser's solicitors, seeking information from client where necessary
- Send agreed Contract and Transfer to client for signature



Client

- Reply to enquiries as necessary
- Return signed Contract and Transfer.
- Completion date to be agreed between parties

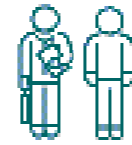


Solicitor

- Open file when instructions received
- Send client forms and letters to complete

Client

- To return:
 - Signed Client Care Letter
 - Completed Essential Client Information Form
 - ID, as required
 - Money on account
 - Deeds and other documents relevant to the property
 - Completed Law Society Fixtures and Fittings Form (TA10).
 - Completed Law Society Information Form (TA6) (Freehold only).
 - Completed Leasehold Property Information Form (TA7) (Leasehold only)



Solicitor

- Exchange, with completion on agreed date, with client's authority.
- Notify client and estate agent

Client

- Arrange removals

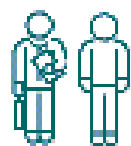
COMPLETION

Solicitor

- Receive money
- Redeem mortgage
- Pay estate agent
- Send balance to client
- Confirm completion and release of keys to client and estate agent

Client

- Take final meter readings
- Aim to be out of property by around lunch time
- Hand keys to estate agent



Solicitor

- Obtain up to date redemption statement
- Provide client with completion statement

Client

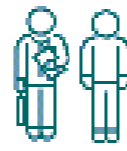
- Transfer any balance
- Confirm bank details to solicitor for payment of balance of sale proceeds (not by email)
- Cancel buildings insurance
- Confirm new correspondence address to solicitor (if necessary)
- Confirm removals (aim to vacate around lunchtime on completion day)

Solicitor

- Open file when instructions received
- Send client forms and letters to complete

Client:

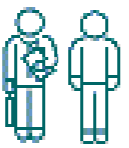
- To return:
 - Signed Client Care Letter
 - Completed Essential Client Information Form
 - ID, as required
 - Money on account
 - Funding arrangement form and supporting evidence
- Organise funding (as necessary)
- Instruct surveyor

Solicitor

- When all relevant documents received:
 - Apply for searches
 - Send Fixtures and Content Form & Plan to client for approval
 - Investigate title
- Raise initial enquiries with seller's solicitor
- Report to client on mortgage offer (when received)
- Send mortgage deed for signature
- Raise final enquiries with seller's solicitor following search results
- Report to client with search results and responses, contract, transfer and SDLT forms to sign and return

Client

- Raise any queries on report
- Sign and return contract, transfer and SLDT
- Agree completion date when satisfied with property report
- When requested, send deposit to solicitor ready to exchange



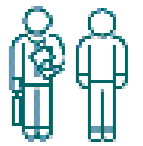

Solicitor

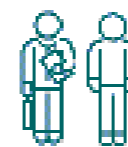
- Prepare pre-completion searches
- Carry out exchange
- Request funds from lender
- Prepare completion statement request balance from client

Client

- Arrange removals
- Put on risk building insurance from exchange and ensure details sent to solicitors
- Transfer balance to solicitors - all funds to be received as cleared by close of business the day before completion.



COMPLETION



Solicitor

- Send money to seller's solicitor
- Inform client once seller's solicitors confirm receipt of funds, which means completion has taken place
- Arrange registration at the Land Registry

- Collect keys
- Take meter readings
