Raising finance for growth

If your institution requires access to additional funding, our Banking and Finance solicitors have the lending connections and expertise to help make the borrowing process as smooth as possible. Members of our Banking, Construction, Property and Education teams recently came together to support a Higher Education college on its aim to deliver a net zero environment by 2030. The Education team advised on the college's existing funding to ensure it was complying with its obligations to the Education Skills Funding Agency. Our Construction team worked with the college's project directorate to put in place all design and build contracts, while our Banking team assisted with the college's funding for the project.

We have recently advised a University in respect of their tender for public funding in order to provide master-level apprenticeship agreements, specific academic course promotion projects and other government-led academic progression programmes.

Commercial contracts and agreements

It is essential that Higher Education providers have sound contracts. Our Commercial team has experience in advising a wide range of education sector contracts – from standard commercial contracts, such as distribution agreements and terms and conditions to specialist research and development contracts.

Members of our Commercial team have provided strategic procurement advice to a University about whether to use a framework or create a bespoke single supplier contract for a campus-wide library software contract.

This included reviewing it from the bidder's perspective to give the client guidance on what the potentially contentious areas were likely to be along with the likelihood of challenges. This work was carried out within a very short timeframe.

We advised another University client on a successful collaboration with a large corporation to establish new commercial income streams. Key commercial terms were advised on, along with an explanation of the risks involved and proposed changes to the contract.

Our Commercial team deal with a variety of education sector licencing and copyright contracts, negotiating with publishers where necessary and advising on the risks associated with remaining warranties.



Governance and regulatory

Growth and change are synonymous with University and Higher Education life – moving with the times is a vital part of moving forward and providing the best for stakeholders in a University community. Our Corporate lawyers are well equipped to advise and deal with needs as your organisation evolves.

Our corporate work for the Higher Education sector includes:

Advising several institutions, including a Higher Education organisation, which intended to join together to form a new entity to promote educational services. We provided an overview of available business structures, following which the client decided to incorporate a community interest company. We are assisting with the establishment of that CIP along with initial filings and will provide a company secretarial service if required.

We have advised a University on the interpretation of its Charter, Statutes and Ordinances in order to determine the approvals required to establish a new operational enterprise. We have expertise to advise on the specific requirements of Higher Education organisations seeking to partner with, or retain in an interest in, a new entity. We are also able to advise on suitable corporate structures depending upon the circumstances which apply, including structures such as partnerships or companies.

In your corner

When contentious events occur, access to sector-focussed advice, support and guidance can be critical. Our Dispute Resolution team have worked with a range of Universities and Higher Education providers, dealing with matters ranging from supplier disputes to student debt recovery.

We acted for a London University for a number of years on a variety of disputes including tenant default, and a rights to light claim relating to a proposed major redevelopment of the central London campus. We have advised on the removal of protestors from a Higher Education College's sports ground, on contested commercial lease renewals and issues related to development agreements.

We acted for a University in South Wales to obtain possession of student hall accommodation following non-payment of accommodation fees.

We acted for an Oxbridge University in response to a First Tier Tribunal appeal concerning information withheld under the commercial interests exception of the Freedom of Information Act 2000.

We advised a University in respect of its legal position for both misappropriated payments and how best to recover sums owing, as well as shaping an insurance claim for them. We are working with IT forensic specialists to decide how best to safeguard against a repeated cyber fraud incident including advice to improve relevant processes and controls, and the measures that can be taken to maximise a recovery should the University find itself in this position in the future.

We advised a University in respect of advanced push payment fraud. Emails were diverted from our client to the fraudster, thus allowing them to manipulate correspondence being sent and also to materially change invoices to divert payments to the fraudster's account resulting in significant financial loss to the University.



Managing your team

We support education sector clients on a complete range of employment law issues including advice and support on contracts of employment, staff recruitment, pensions, policies and procedures. We also regularly advise on day-to-day employee matters such as grievances, disciplinary issues, performance issues, sickness absence, redundancy/restructures, discrimination, TUPE, and settlement agreements. We have experience advising on trade union matters and have extensive experience advising on Employment Tribunal claims. Our immigration team can help bring international staff, students, and their families, to the UK.

We assisted an educational institution during a disability discrimination and victimisation grievance. Raised by an existing employee, the grievance was fully defensible, and resulted in an ACAS pre-action conflict claim. Ultimately, the dispute was resolved via a settlement agreement through the Employment Tribunal before a claim was lodged for commercial reasons to avoid management time on defending the prospective claim.

We advised an educational institution on defending a complex sex, race and age discrimination claim. We applied to strike out the claim on the basis that it had no prospect of success. We were successful in persuading the tribunal to order the claimant to pay a deposit in relation to each claim, indicating that they were at risk of paying costs if they continued the claim.

We have experience of working with the unions UNISON and UCU in relation to staff restructuring.

We advised an Oxbridge College in relation to employee worker status. Specifically, we were retained in regard to potential risks that tutors who are engaged from a different college or who are not members of a college, may be deemed to have worker rights for employment law purposes, rather than being self-employed.



Staying on the right side of regulations

Compliance

Universities and Higher Education institutions are as subject to regulatory requirements as any other business and often moreso than any other business. Ensuring compliance with regulations – whether that be with regards to the DfE, OfS or CMA more generally, health and safety, finance, insurance, the environment or anything else, our regulatory team are vastly experienced in advising on complex and urgent issues.

We advised a leading examinations board as to a major regulatory investigation.
The CEO of the board was required to give evidence before the House of Commons
Education Select Committee. We advised the board concerning the attaching of
Parliamentary Privilege to answers given to the Committee.

Health and safety

Our team of health and safety lawyers advise a range of clients, from SMEs to charities, schools and international companies. The team handles a diverse workload, including providing advice in respect of an organisation's duties and obligations along with practical advice on putting in place an effective health and safety management system.

We successfully represented a University estates department following a major electric shock accident arising in the course of construction works. The injured parties had life changing burns. Health & Safety Executive investigations lead to a threat of criminal proceedings including a considerable fine. We successfully defended the university, including in terms of its procurement process, and management and co-ordination of contractors.

During and after the Covid-19 pandemic, the health and safety team advised numerous organisations in respect of safely returning to work. In addition to the provision of specific advice given to clients, we ran a number of webinars, without charge, to assist clients with understanding the necessary principles to consider when setting return to work policies.

Providing advice to a Higher Education organisation catering manager on the risks posed by preparing meals for students with known food allergies and pre-packed for direct-sale foods where students with food allergies self-select wrapped products.

Providing advice to a Higher Education institution regarding its student accommodation policies during investigations by the fire service and environmental health office. These investigations arose following fires within student accommodation, blocked fire doors and falls from windowsills due to missing, or damaged, window restrictors.



Insurance

Our established Insurance and Risk team provides comprehensive support across a range of industry sectors. Insurance advice involves an appreciation of relevant risks to be managed and the client's requirements in regard to protection and prevention. This all becomes more complex as the risk environment increases, as it does in the education sector. The consequences of poor risk management can have significant reputational and financial outcomes.

Our insurance and risk advice services for Colleges and Universities are built on considerable sector expertise. HCR has developed a total risk proposition to support organisations meet these challenges. Where instructed our approach will be based on:

Insurance due diligence

A review of a University or Higher Education organisation's insurance cover to ensure that key risks are effectively covered, that limits of insurance are appropriate, that a policy will respond when a claim arises and that the risks posed to cover by harmful exclusions are identified and mitigated.

Crisis management

If a crisis hits, a Higher Education institution risks losing its reputation, revenue, respect, value, and trust, as well as potentially its registration. Through pre-crisis planning, training, and exercising we can support to build organisational capability, confidence, and resilience to overcome the challenge of a major incident. With sound counsel we guide organisations through their crisis response when things go wrong.

Claims defensibility

A detailed understanding of the legal, procedural and claims management processes that help education institutions ensure they are best placed to deal with investigations, and can defend prosecutions and claims.

For the education sector our Insurance team has defended many claims and incidents arising from employers' and public liability claims, abuse, bullying, harassment and stress claims, claims of failure to educate, Health and Safety Executive and other regulatory investigations and prosecutions, inquests and property damage.

Environment and planning

Our Planning, Highways and Environment team advise on every aspect of planning and highways law. This ranges from issues which may be preventing development such as village greens, public rights of way or asset of community value applications. The team is also experienced in advising on challenges to planning decisions in court or in defending enforcement action. Our Environment team advise on nature conservation, water pollution and waste regulations amongst others, as well as acting for clients in bringing and defending legal claims.

Public procurement

Where a University is a 'contracting authority' as defined under the public procurement law regime, there are specific requirements which apply to the tendering of contracts for works, services and supplies. We have specialists who can advise on keeping on the right side of the regulations which apply when it comes to preparing a tender strategy. We can help from the initial advice stage on structure - for example advising on whether to use a framework or draft something bespoke - and timetables, to drafting tender packs, participating in dialogue meetings and helping to evaluate bidders. We also have broad expertise in advising on public procurement challenges to tenders including pre action and in the High Court.

We advised a Higher Education College on the procurement of a new IT system for the management of admissions. A range of procurement options were advised on, including the College's original plan to develop a bespoke tender process. Ultimately the college took advantage of an existing education sector IT framework which saved considerable time and cost.

We advised a Midlands University on the applicable public procurement procedure relating to tendering a social care training contract. The University had established close links with a number of community social care charitable organisations which were in receipt of public grants for relevant education and training. We advised the University on a three-year contract concluded pursuant to Section 7 of the Public Contracts Regulations 2015.





Developing property and land

We advise on all aspects of real estate transactions: from acquisition, development and funding through to asset management and disposal. We have specialist commercial property, real estate dispute resolution, planning and construction solicitors, and public procurement law specialists – so we can take clients through a real estate position, what ever stage the University or other Higher Education body is at.

Our Estate Management and Construction team has advised on numerous university construction projects and are currently advising a Central England University on consultant and contract documentation for a new £25m library and teaching facility project.

Advising on the redevelopment of historic kitchen and related accommodation facilities at an Oxbridge College, including advice on the appointment of the project team, negotiations with the preferred contractor and related documentation.

Advising on the development of a city centre campus project – including procurement advice, advice in relation to the strategic refinance and planning/highways issues.

Our Planning Law team has been integral to development projects for universities.

We have recently advised a University on several development projects including the demolition of student accommodation and the redevelopment of the site for residential use.

We have also acted for an open-campus University to prepare a strategy to prevent new public footpaths and recreational rights being established.
