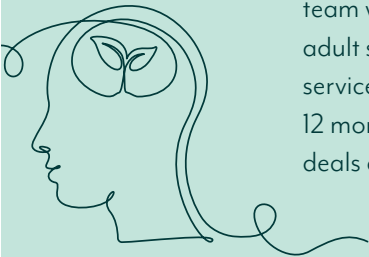
Agriculture, Environment and Estates

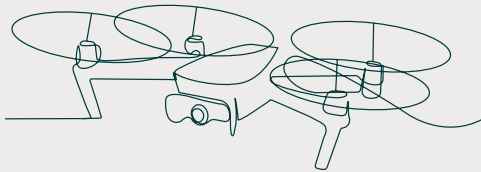

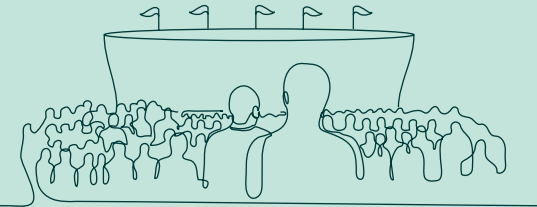

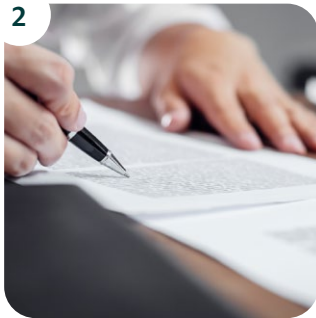
